

Declaration of REACH (EU/UK), RoHS (EU/China), Proposition 65, Biozid and POP-compliance

in the following we confirm the REACH (EU/UK), RoHS (EU/China), Proposition 65, Biozid and POP-compliance of our products.

REACH Regulations (EC/1907/2006), (UK S.I.2020/1577) and Waste Framework Directives (EC/2008/98 and EU/2018/851)

As a manufacturer of vibration and noise-reducing products, Hutchinson Stop-Choc GmbH & Co. KG is called "downstream user" in terms of REACH Regulations. In addition, no substance should be released from the products you purchase under normal and reasonably foreseeable conditions of use, Hutchinson Stop-Choc GmbH & Co. KG does not generally have to register.

According to our suppliers, the materials we use do not contain any substances from the respectively **up to date** SVHC candidate list (substance of very high concern) in a concentration of more than 0.1 percent by mass and free of PFAS. Hutchinson Stop-Choc GmbH & Co. KG guarantees that it will monitor the updates of the REACH requirements, in particular the expansions of the candidate list and the inclusion of substances in REACH annexes and compare them with the substance information.

Of course, we stay in constant contact with our suppliers. For each order, we oblige our suppliers, for each order item individually, to assure us of compliance with the current REACH regulation for the materials purchased from us. If we find that our products are subject to notification under Article 33 REACH, we will include them in the SCIP database, maintain it and inform you about it. Compliance with the EC 2019/1021 POP Regulation and EC 2012/528 Biocide Regulation is hereby confirmed.
